**ARTICLE VI, SECTION 4-USE RESTRICTIONS**

**SECTION 4. SWIMMING POOLS.** All lots in the community known as Arbor Creek Subdivision in Plainfield, IL are allowed to install in ground, ½ in ground, and above ground pools when installed in accordance to Village of Plainfield, IL Rules and Regulations noted in the Municipal Code, Chapter 2.5 Building and Building Regulations, Article VII, Swimming Pool Regulations, Section 2.5.
